



Safety Net Hospitals for Pharmaceutical Access

Dear Children's Hospital:

Because you are now eligible to participate in the federal 340B drug discount program, we are writing to invite you to join Safety Net Hospitals for Pharmaceutical Access (SNHPA) so you may further maximize your savings on pharmaceuticals while complying with a challenging and ever-changing array of federal regulatory requirements. SNHPA is a Washington, D.C.-based non-profit organization representing over 700 hospitals nationwide, including 22 children's hospitals. SNHPA is the only organization in the country whose primary purpose is to educate 340B hospitals and advocate on their behalf. Attached is our Membership Packet.

Thanks to advocacy by the National Association of Children's Hospitals and SNHPA, discounts on "orphan drugs" have now been restored. Children's hospitals use many of these expensive drugs on a daily basis to treat conditions including cystic fibrosis, pediatric cancers, respiratory distress in premature infants, juvenile arthritis and cerebral palsy. We are delighted that we were able to reverse this provision and are working to ensure that children's hospitals receive retroactive relief if they were denied such discounts.

In 1992, SNHPA led the effort to ensure that Disproportionate Share Hospitals (DSH) were included in the 340B program, and we have been working closely with Congress and the government in implementing the program ever since. Since the inception of the 340B program, SNHPA has assumed the lead role in protecting it from attempts to repeal or restrict it. Right now, the pharmaceutical industry and the National Community Pharmacists Association are stepping up their efforts to restrict 340B to just uninsured patients, and the federal government is considering patient eligibility restrictions. At the same time, regulators are scrutinizing the program to assess whether 340B hospitals are complying with the law's billing and anti-diversion requirements.

One of the most challenging areas of compliance involves tracking and managing drug inventories in hospital settings where both inpatient and outpatient drugs are used. To help members navigate compliance in these "mixed use" settings, SNHPA has issued helpful guides on inventory management software as well as reports on restrictions against group purchasing, duplicate discounts, diversion, and so-called "cherry picking." You may also consult by telephone with SNHPA's expert staff and counsel at no extra charge.

Helping our members with compliance questions and capitalizing on opportunities for better prices are not the only benefits we provide. SNHPA has launched an ambitious program to assist members in identifying and collecting refunds on drugs for which they overpaid. SNHPA has been working closely with government investigators, resulting in tens of millions of dollars in refunds to our members. Other benefits include regular news

updates about important 340B developments, a free subscription to our online publication, *The Drug Discount Monitor*, access to the Members Only section of SNHPA's Web site (www.snhpa.org) and invitations to webinars, national meetings, and regional roundtables. SNHPA members are also able to share strategies on cost-savings techniques through communication on our listserv as well as at SNHPA events.

One of our most exciting initiatives is to enact legislation requiring manufacturers to offer 340B discounts on all inpatient drugs. Legislation that would accomplish that goal was included in the health reform bill enacted last year but removed at the last moment as a concession to the drug industry. In 2003, SNHPA was able to convince Congress to enact legislation making it easier for DSH hospitals to access discounts on inpatient pharmaceuticals voluntarily. However we still need to convince the government to allow children's hospitals to have this same benefit and ultimately require manufacturers to provide discounts on all inpatient drugs. We are also working to ensure that children's hospitals are able to utilize 340B discounts at sites that are 35 miles or more from the main hospital. DSH hospitals already have this right. If we are going to be successful in accomplishing these goals, we need your support.

In addition to our focus on the 340B program, SNHPA also plays an important role in educating our members about pharmaceutical manufacturer patient assistance programs (PAPs). We provide advice on how to maximize use of these opportunities while ensuring compliance with anti-fraud and other requirements.
